

AUTHORIZATION FOR THE PROCESSING OF PERSONAL DATA

By registering, I hereby declare that: I understand and accept that **LA FUNDACIÓN BOLÍVAR DAVIVIENDA**, identified with Tax Identification Number 860.076.173-2, and **FUNDACIÓN CULTIVA EL ARTE Y LA CULTURA**, identified with Tax Identification Number 901.186.943-7 (hereinafter, jointly identified as LA FUNDACIÓN), both located at Calle 26 (Avenida El Dorado) No. 69-63 Piso 11, Bogotá D.C., and Phone number: (1) 2201610, will require the use of my personal data, as well as that of my minor child(ren), for the following purposes:

GENERAL PURPOSES FOR STAKEHOLDERS:

1. To verify reference data and, in some cases, to know and track financial suitability, business behavior.
2. To participate in the different programs, activities and events performed directly by LA FUNDACIÓN or through partnerships with State institutions, civil society, educational and private sector, foundations or social organizations.
3. To perform an analysis of interests and preferences, seeking to offer or develop programs, projects and activities that fit people's needs.
4. To evaluate, maintain, improve and deepen the impact and evolution of LA FUNDACIÓN's programs.
5. To provide information regarding events, news, communication, and marketing related to LA FUNDACIÓN in the development of the foundational programs.
6. To disseminate LA FUNDACIÓN's activities on television or radio programs, web pages, streaming, social networks, video exchange platforms and/or editorial or advertising material produced by LA FUNDACIÓN.
7. To keep accounting records. As well as, to provision and execute the payment and/or collection of the contributions made.
8. To market products and services in order to support the sustainability of LA FUNDACIÓN's social, creative, cultural or artistic projects.
9. To transfer basic contact information; that is, full name, identification card, and email, to entities that can complement the offer to our beneficiaries, in such a way that they identify the Data Subject as LA FUNDACIÓN's current Beneficiary, and contact him/her for the offer of new services.
10. To transmit personal data abroad to third parties with whom LA FUNDACIÓN has signed a data processing agreement and, if necessary, to deliver them to fulfill the contractual purpose.

13. To control access to the facilities and guarantee the security of the people who participate in the program.

ADDITIONAL PURPOSES FOR THE ARTISTIC CONTACT:

1. To be contacted in order to find out the current status of the artistic process carried out with the Institution's students.
2. To provide support from the Filarmónica Joven de Colombia so that they can complement the artistic process.
3. To invite them to continuous training processes, for their professional development, performed by LA FUNDACIÓN or through its Allies, with whom there is an agreement.

ADDITIONAL PURPOSES FOR THE PRACTITIONERS:

1. To control and follow-up the social practices performed at the Cultivarte headquarters.
2. To certify the Educational Institution regarding the performance of the social practice.
3. To generate internal statistics of the activities performed by the practitioner.
4. To contact the social practitioner's guardian in case of medical emergency, personal incidents, natural disasters and/or any event that puts the minor's integrity at risk.

ADDITIONAL PURPOSES FOR THE PLAYMAKERS:

1. To generate internal statistics of the activities performed at the Cultivarte headquarters.
2. To send details of the Cultivarte program.
3. To locate the family member or contact person in case of medical emergency, personal incidents, natural disasters and/or any event that puts my integrity at risk.

ADDITIONAL PURPOSES FOR THE MEMBERS OF THE MAYORS' OFFICES:

1. To develop the specific activities of the alliance, including sending relevant information to execute the agreement, perform it and terminate it.
2. To generate and/or send statistics or reports of the activities performed at the Cultivarte headquarters with whom there is an agreement.
3. To send details of the Cultivarte program.
4. To contact them in the event of a medical emergency, personal incidents, natural disasters and/or any event that puts the integrity of the people who attend the Cultivarte venues at risk.

All of the above, through the sending of short text messages (SMS), multimedia messages (MMS), email, mobile phone, landline, physical mail and digital or similar means.

By virtue of these purposes, as mentioned in the introductory section of this authorization, data regarding minors will be processed, as well as information of a sensitive nature, such as photographs, videos, voice, fingerprint and health-related information, where its provision is optional. I understand that this information will be used with full respect for the Data Subject's rights, and from now on I explicitly authorize its Processing.

Likewise, in the event that I have included in this form the contact information of beneficiaries who are adults and minors, I have been informed that the purpose of processing this information is that they acquire such quality and can access all the benefits offered by LA FUNDACIÓN. I hereby declare that I am aware that the authorization of personal data of minors is optional and that the purposes indicated herein are related to their best interests. In the event of beneficiaries of legal age, I have been informed that I authorize, on their behalf, through the stipulation in favor of, or for another, given they will only receive benefits from LA FUNDACIÓN, as per Article 2.2.25.4.1. of Chapter 25 of Decree 1074 of 2015.
